Fire Department (FD)/John Young. Has been quiet/only one call. Mayor Wise advised that OTEC made a \$1500 donation to the FD.

Gaslin Accounting/Bills: Provided Council with February bills to be paid for the month, to include grant payments. MSP: Pay the bills as presented. Councilor Brandt/Councilor Demaris. Mayor Wise, Councilors Brandt, Briscoe, Demaris, Smith voted to approve. Mr. Gaslin went over the appropriations list. Councilor Demaris asked about audit; Mayor Wise advised it is still in process.

SVRR President Loretta Henry as asked to meet with Mayor Wise on 3/18/25 to discuss 2025 schedule & their 50th anniversary in June, 2026, and involving the community. They are inquiring about utilizing the fire hydrant near the Sumpter station for water when they run the steam engine this year. John Young advised hose with nozzle has been left at hydrant in past. CITY OF SUMPTER COUNCIL MEETING MARCH 11, 2025

Address Assignment, Lot 2900: Review of the address assignment map, previous Zoning application, and Council discussion, it was recommended that Lot 2900 be assigned address 840 Cracker Street. MSP: Assign Lot 2900 address 840 Cracker Street. Councilor Demaris/Councilor Smith. Mayor Wise, Councilors Brandt, Briscoe, Demaris, Smith voted to approve.

Volunteer Park Grant Update: Matt Armstrong made a presentation in regards to obtaining the play structures, type of surface and the pricing which at this time is estimated at \$151,781. Council discussed options for the playground surface. It was discussed that this is a reimbursement grant. It was suggested we revisit the structures and surface we would like to possibly lower price; and, other additional grant funding. Mr. Armstrong will look into other options. He further advised Council that the deadline for under \$100k grant is April 9 and over \$100 is April 30. A Workshop was scheduled for March 24,205 to continue discussion.

Cemetery Project/Grant: Mr. Armstrong advised that the \$8000 grant request is due end of April. The plan for this grant is to replace the perimeter fence. Other plans are volunteer and donations for grading the proposed site and cleaning up the existing area. As voted last year, the City will pay equipment fuel. The Fire Dept would sponsor BBQ for the volunteers for the existing cemetery area clean up.

Resilience Hub Grant: All the paperwork submitted. City awarded a \$25k grant submitted by Baker Co Emergency Management Awarded grant is for a generator, transfer switch, and connection to propane for the Community Center.

Cross Connection Training Recertification: Tim Jacobson is required to take 6-hour recert course. Cost is \$200. MSP: Councilor Smith/Councilor Briscoe. Mayor Wise, Councilors Brandt, Briscoe, Demaris, Smith voted to approve.

ADA Curb - Concerns, such as, safety – trip hazard, who is liable for plow damage, if they will be putting in a pad and grade up to it. Tabled until return call received.
