## 1) CALL TO ORDER – 4:00pm

- a) PLEDGE OF ALLEGIANCE
- b) **MEMBERS IN ATTENDANCE** –Councilor Wise, Councilor Demaris, Councilor Leuenberger, and Councilor Briscoe. Mayor Lucas, absent.
- c) VISITORS- Kimberly Ballard, Jon Patterson, Rebecca Patterson, Vern Hollopeter, Kurt Clarke, John Young, Leanne Woolf, Albert Jones, Sherry Brandt, Mike Merritt and Kim Merritt.

### 2) Approve Minutes

- a) Councilor Leuenberger said, "It seems to me the discussion with Mr. Young is a little light on the factual information, and who said what. And the same with number eleven, I hate to short Jon Patterson, he was mentioned also." The Recorder pointed out that public comment is to address the Council and not to comment in general. Councilor Wise asked Councilor Leuenberger what he specifically wanted added to the minutes. He couldn't say exactly what, he just wanted more, however he did want assurance that the emails from Dawn Kitzmiller would be part of the minutes. The Recorder read from the minutes (5 F) pointing out that the assurance was in the minutes themselves. ## 3) Fire Department-Kurt Clarke

- a) Sumpter is under extreme fire conditions. No mowing or weed eating dry grass is permitted. To include electric equipment.
- b) Training is going well.
- c) During a previous meeting the pump repair information was incorrect. The volunteer fire department members were not at fault for the pump needing repaired.
- d) The grounds should be watered a little before the Labor Day flea market.
- e) A letter could be sent out to owners of property with tall grass and ask them to mow it to reduce the fire hazard.

## 4) Public Works-Tim Jacobson

- a) The non-chlorinated fire hydrant has been shut off in the street. It causes problems with the pump at the filter beds to have water drawn from this hydrant.
- b) Once the parts to take the Redwood tank offline comes in, the work will be done.
- c) Mr. Brooks, Warrenton Construction, looked at what it is going to take to get the Redwood Tank offline. No excavation or vault will be needed. All of the work can be done inside the water building. This will save the City a lot of money not having to dig and move power to complete the job. Mr. Brooks will be providing the City with a new estimate.
- d) Levi Tickner is responsible for figuring out how to save time and money on the Redwood Tank project.
